POLICY ON FEES

Deposits

A deposit of £500 is payable when accepting or holding a place at the Nursery. The deposit will be refunded after the fees have been paid, provided parents give two months' written notice.

Calculation of fees

The fees are calculated by multiplying the weekly amount by the 51 weeks that the nursery is open, and dividing that figure by 12 calendar months. A 10% discount is applied when calculating fees for 5 days per week.

The nursery is closed for one week in total during a year (at Christmas). There is no charge for this closure.

Fees increase annually from January. The sibling discount applies to families with two or more children attending the nursery (deducted from the lower fee).

Payment of fees

The full fees are required to be paid to the nursery at the beginning of each month. If the fees are not cleared by the end of a calendar month, the nursery reserves the right to temporarily suspend the space until the fees are settled.

Vouchers, tax free childcare and other schemes

Most companies run a payroll tax deduction (vouchers), or you can sign into tax-free childcare. Brook House Nursery is registered with most schemes involved.

Absence

If your child is absent, for any reason including illness and holiday, full fees must be paid, as the costs of staff, business rates, heating and lighting still need to be met.

If your child attends two days a week only and one of those days is Monday, we will try to give time back for May and August Bank holidays. This depends on availability.

Extra days

If you require some extra day/days we will try to accommodate this depending on availability. The cost of this is detailed on the fee schedule and will be invoiced to you.

Government funding

All 3 and 4 year old children are able to access 570 hours of entitlement hours funded by the Government from the term after their third birthday.

At Brook House Nursery this funding is stretched over 51 weeks per year.

Your Universal 15 hour entitlement will be provided free at the point of delivery. We do, however, charge for the additional hours provided outside the entitlement hours, as well as extras including meals and activities.

30 hours Extended entitlement

The government also offers extra 15 (extended) hours a week of funded childcare, to working parents of 3 and 4 year olds, who meet the eligibility criteria.

Currently, Brook House Nursery offers extended hours for families whose children attend the setting for 4 or 5 days per week.

The expanded offer

From April 2024, eligible working parents of 2-year-olds can access 15 hours childcare support for 38 weeks per year. Brook House Nursery stretches the funding over 51 weeks.

From September 2024 15 hours childcare support for 38 weeks per year will be extended to eligible working parents of children from the age of 9 months to 2-year-olds. Brook House Nursery stretches the funding over 51 weeks.

Changes to number of days

It is possible for you to secure your child's place up to six months before their start day. Please note that if you decide to reduce the number of days prior to your child starting at the nursery, you need to provide us with a minimum of three months' written notice (e.g. email).

If you change your days less than three months before starting, we reserve the right to withdraw your place. If, however, we are still able to confirm your place, full fees for the original number of days would still apply for the first month.

Once your child has joined the nursery, if you would like to reduce the number of days, you need to provide us with one month's written notice (e.g. email).

Changes to start date

Prior to joining the nursery and once the deposit has been paid, you may delay your child's start date by up to two weeks.

If you decide to delay your child's start date by more than 2 weeks, your place will be withdrawn and you will go back on the waiting list, and you will lose your deposit.

If you would like to ensure that the place is reserved for you, full fees will apply from the original start date.

This also applies to siblings.

Withdrawal

If you would like to leave the nursery you need to provide us with two months' written notice (e.g. email).
